

SALE OF ADULTERATED OR EXPORT BOUND MOTOR FUELS IN THE LOCAL MARKET

The Energy Regulatory Commission is mandated under Section 95 of the Energy Act 2006 to monitor petroleum products offered for sale in the local market with the aim of preventing motor fuel adulteration or dumping of export bound fuels. In this regard, the Commission undertakes a program of continuous monitoring of the quality of petroleum motor fuels being sold throughout the country.

During the months of September to December 2015 the non-compliant stations and their particular offenses are listed here under:
